Board of Director Chair's Annual Report

Greetings Fellow Siblings in Christ,

I hope this report finds you well as we move through our Lenten season and prepare to celebrate the new life that is given to us in the Easter season through Jesus. I stepped into the role of Board Chair two years ago, taking over from Rev. Chris Leach with the hopes to continue his good work as chair. While the year has certainly had its challenges, it has also been filled with a lot of blessings. Through it all, I'm grateful that we have this opportunity to be in ministry together and to be partners in building faith in our little corner of the Church. I'd like to use this report to share my sincere gratitude to our staff, as well as my excitement about the time ahead.

The Year-Round Staff of Pathways: I am so grateful for the hard work and dedication that our Program Director Kale Johnson has shown this past year. Kale has worn many hats around Pathways and we're grateful to have their steady leadership and passion for sharing the love of Jesus with God's people. Throughout 2023, we welcome Jerry and Carolyn Fritsch into a shared role of Interim Executive Directors. They brought their years of experience in Lutheran outdoor ministry to get a fresh set of eyes on so many aspects of our operation and were able to help us get our feet underneath us and laid the foundations for the next season of ministry at Pathways well. I'm very grateful to Ira Bailey for stepping in following the Fritsch's departure to step in that role with such humble positivity and love of our shared ministry. In September, we welcomed Paige Johnson into her role as hospitality and outreach coordinator, and she has brought such joy to her work — as she has on many summer ministry teams in the past. Last, but certainly not least, I'm grateful to our Facilities Guru, Brad Fossen. Brad has spent nearly two decades on board at Pathways and I'm so thankful for him and his steady behind-the-scenes leadership.

The Summer Ministry Team: To me, it always seems like something of a miracle every summer when young adults come together from around the world to be at camp and walk alongside young people growing in their faith. The ways they gave of themselves for the sake of others – even when they're running low on sleep – is a testament to their passion for the ministry of Pathways and I continue to give thanks for them. (And if you know of an 18+ year-old who has a passion for sharing their love of Jesus with others and would love to spend their summer in the great outdoors, let us know!)

Ministry Partners of Pathways: I've been blessed to be a part of the ministry of Pathways for almost 20 years now. I was on summer staff beginning in the summer of 2005. I spent many summers with young people growing in faith that ultimately led to a call to ordained ministry, which led to bringing young people to camp as their pastor. Now I bring my own kids to camp as a parent. I'm grateful for each step of the journey. I'm grateful to each and every one of you who support the ministry of Pathways through your prayers, your generosity, and all the ways you pay forward the impact God has made in your life through your partnership with us. Thank you for your prayers. Thank you for your generous support. Thank you for sharing this road of faith together.

I believe we stand on the edge of a powerful opportunity for Pathways. After many years of prayer, listening, and discernment, the Pathways Board brings a motion to this Annual Meeting to go all-in on Camp Emmaus as our residential ministry hub. *In order to accomplish this, we bring a motion to you as the constituency to pursue the sale of Camp Minne-Wa-Kan for the funding necessary to invest at Camp Emmaus*. The realities of outdoor ministry in a post-pandemic world have weighed heavily on our board as we've faced difficult decisions about stewarding our resources responsibly and how that impacts the ministry we're able to do. At a Pathways Constituency Meeting in May of 2022, you overwhelmingly voted for us to pursue the purchase of Camp Emmaus for the continued residential ministry of Pathways. We, as a board, have accomplished this and are looking to build on that work for the sake of our continued ministry.

Our mission has always been to offer unique environments where God continues to encounter people and renews them to live lives of love. I'm grateful for the work of this board in helping us move forward to the point where we are today. I'm excited for the ways God will continue to lead and guide us. Executive Director's Annual Report

Greetings!

2023 was a year of transition for our staff leadership team! We are grateful for another full year of wonderful ministry from our Program Director Kale Johnson and for Brad Fossen keeping the camps together as our Facilities Director! Beyond that we've had change. We welcomed Paige Johnson as our new Outreach and Retreat Coordinator. She is also taking care of the office duties. We're working together to make this little staff succeed. We're grateful for the work of Chris Andreasen as Executive director and Jerry and Carolyn Fritsch for their time from April through September. Eric Clapp and the rest of the Executive Board carried a lot of weight through these transitions and we're grateful for their leadership.

If you have looked at the financials, you know that we have a severe deficit and everyone needs to work to make a difference. Last year should show us just how important it is forPathways to have a full time dedicated director to lead the organization. It is critical to have a voice building relationships, telling businesses about us and letting you, our donors and churches, know how important you are. As we learned in our devotions at the Conference Assembly meetings, Camping ministries are second only to Sunday School for inspiring future

ministers. Your attendance, prayers and support are the future of our camping ministry. Conferences one through six need Outdoor Ministry so we can continue inspiring young people to live lives sharing the Gospel and God's Love for All!

My work as the Interim Executive Director began in October and I am looking forward with hope for the future of Pathways. I have been a board member since 2020 and I hope to continue working to complete the sale of Minne-Wa-Kan, replace and refurbish the cabins at Emmaus, continue to build our relationships with our churches and find the right person to lead this fabulous organization into the future!

The staff and board believe Pathways is an asset to our churches and we will be working in 2024 to find out what we can do to assist each congregation. We'll need your help to do this, so invite us to your church to visit, participate in worship with you and lead your Day Camp. We also hope you come to camp with your youth this summer and for retreats in the fall, winter and spring! This asset is only an asset when you use it!

The board voted in August to move on from our ownership and leasing out of Camp Minne-Wa-Kan. Our vote as an organization to hopefully support this decision at our annual meeting on March 17, 2024 is a crucial event in our plan to successfully revive Pathways and lead us into the future with a plan for that future. I understand that this is an emotional time for many whose faith formation is closely tied to that sacred ground. I understand the love for camp. My wife and I met at White Earth Lutheran Camp. It was given to the White Earth Tribe before the merger. I loved that sacred ground, but it was time to let it go and become what it needed to be.

I have been attending the Conference assembly meetings over the past couple of weeks. We have one left in Bemidji on Tuesday the 19th. We have been received warmly and everyone was supportive of the camping ministry. I shared our plans for the sale of Minne-Wa-Kan and the improvements for Emmaus as well as our desire for a closer relationship and two way communications. The devotions at the assemblies were about the importance of our Youth Ministries. The top four ministries to encourage and draw pastors and rostered ministers into a life of ministry as a vocation are: 1. Sunday School 2. Camp 3. National Youth Gatherings and 4. Campus ministry. It is crucial that we all support camping as a pastor development tool!

I have been in contact with AI winterberger, the septic designer for Camp Emmaus, he has gotten our usage flow to stay below 10,000 gallons. This is important because when you go over that amount, the control moves from the county to the state, which requires more oversight and significant costs to maintain. Due to all of these delays, he has assured me that the June 15 deadline will be pushed out to fall. So, we should be able to have the bids ready and allow construction to begin as soon as the summer camping season is completed. We have had several churches donate to this fund and we have those donations restricted for that project. More support for this necessary project are welcomed. The estimated cost is currently \$54,000, but bids have not been requested at this time.

While we are going through a difficult financial time here at Pathways, I am optimistic that we will come out of it in a much better place than when we went into these times. We have a vision for facilities and plans to get there and dreams of programing growth and improvements that will allow us to continue sharing the Gospel and God's Love for all!

As a part of our long term plan for Camp Emmaus, we are planning to move our offices to the camp. The board and staff feel strongly that we need to be there to build our place in the community. Being a part of our community in Menahga will allow us to know people and be known to enable us to do more hiring of people

who live nearby to help us in staffing our ministry. We look forward to having staff on site for our retreaters and campers and better communication between staff and our partners. We will be posting volunteer opportunities on our website soon to help with this and Work Days at both the camps soon. Please help when you can!

We are grateful for the prayerful support from our churches and know your support comes to us as financial support, prayers for our ministry, and sending and being campers, retreaters and Day Camp participants. We're also asking for you to communicate to us how we can be of greater service to your ministry.

We look forward to our future ministry together. This year, as we look forward and transition, we'll look back at fifty-five years of ministry at Pathways, nearly eighty years of ministry at Camp Minne-Wa-Kan and the Ninetieth Anniversary of Camp Emmaus. We hope you will come to Emmaus on Saturday, August 10, 2024 to celebrate another year of camping and the great history of the camping ministry that Pathways is grateful to be a part of in 2024!

Program Director's Annual Report

Dear Pathways community!

What a whirlwind this past year has been! Even with all of the changes, and many hats I needed to wear, we had a full year of building relationships, providing meaningful experiences to our campers and bringing the joy of camping ministry everywhere we go.

When talking about each summer, we tend to use numbers to measure success. However, these numbers aren't able to fully measure the impact of experiences like camp. Looking at an Excel spreadsheet, you won't exactly see the ways God encounters people through camp. And yet, no matter how big or small, these numbers each have a story to tell.

This past summer, we had 319 campers onsite at Camp Emmaus - including 21 of our youngest campers who eagerly explored camp for the first time with an adult in their life. With songs, games, snack and bubbles, they enjoyed a morning full of faith and fun. 39 adventure campers biked trails at Itasca State Park, grew in confidence and character at the Character Challenge Course in Park Rapids, ventured down the Crow Wing river and grew together in their walk with Christ. As we shared about the Wholly Love of our Triune God, we traveled to 14 churches to bring camp to 420 Day Campers. With crafts, worships and new friendships made, we traveled from place to place sharing God's grace. This summer camp ministry of Pathways was led by a team of 18 young adults, who chose to answer the call to lead and give it their all . 3 of these ministry team members joined us as international counselors. Traveling to an unknown land and learning about our culture, they stepped out of their comfort zone to join the whole team in providing unique environments, creating memories and teaching about faith through words and actions. With a total of 101 Bible Parties, each camper's faith grew, including our summer staff whose faith grew

too. From the summer, there are many stories of outdoor adventures. 169 taco in a bag meals were enjoyed at campsites, with 53 tents pitched as some of our campers learned how to do this for the first time. 30 canoes brought campers down the Crow Wing River as they paddled and enjoyed the awe-inspiring beauty of nature. Back at Camp Emmaus, we kept cool in the summer heat by holding at least 8 all camp swims. Friendships were formed with cabinmates, and campers from other cabins, as they participated in a total of 30 all-camp games like Capture the Flag and Bonkers. With missions to complete and fun to be had, these new friends laughed and trekked all across camp's land. On Thursdays they hiked out to our cookout sites to make lunch together, enjoying 222 cookout meals. Speaking of meals made over the fire, we can't forget about dessert. S'mores are almost synonymous with camping. By the end of the summer, counting both traditional and tortilla style s'mores, there were 329 made - well, probably more! As we ate these delicious meals and desserts, 179 goofy and melodic graces were shared to thank God for all the food that was prepared. Besides these meal prayers, there were at minimum 697 other spoken prayers throughout worship and devotions. As each night ended with a campfire worship, 58 of those to be exact, thousands of songs were sung to praise our loving God. Now all of these things don't even include the countless friendship bracelets made, minutes swam in Lake Morgan or pool noodles scooped during Mighty Mighty Scoop Noodle Challenge. There are just some things that can't quite be counted. And numbers can't measure the smiles shared between new friends or laughter of a cabin...or each life-changing, faith renewing experience. But our hope is that this gives a glimpse into all the ways "God encounters people and renews them to live lives of love" through the ministry of Pathways.

Beyond last summer, we were grateful to hold a Jr. High retreat with youth from Zion in Warroad at Camp Emmaus last fall. It had been awhile since we held a programmed youth retreat and it was a joy to help put it all together. Through collaboration with church leaders, we also have a Sr. High retreat happening at Camp Emmaus this coming Friday! Over the winter, time was spent in connection with other program directors and year-round camp staff through conferences and retreats. This networking was such a benefit as I continue navigating my way as an outdoor ministry leader. Paige and I also helped put on a hybrid youth lock-in/youth-led Sunday service at Moe and Messiah Lutheran in Roseau this February! We are excited about all the possibilities of events like these in the coming months and years.

And now we look forward to the summer ahead! In order for us to provide these experiences and help our ministry thrive, we need more folks to join in. It has gotten tougher to recruit summer staff and we need to rely more and more on relationships and connections. To fill the roles needed to provide our programming on-site at Camp Emmaus and at congregations through Day Camp, we need your help. Please reach out to young adults in your life and encourage them to apply! The leadership skills, vocational clarity, social skills and resiliency learned through working at camp over the summer, are just some of the amazing benefits for young adult leaders. We are also looking for people to help with maintenance and join our kitchen crew! All of our employment information can be found on our website, or you can reach out to me any time.

A Ministers in Residence Program has also been put together to encourage pastors and deacons to join us at camp throughout the summer. Through this program, rostered leaders will take part in camp activities, share their own faith stories, provide pastoral care to our staff and campers, and more! Consider reaching out to sign up for a week to be at camp with us this summer!


The rest of this spring will be spent putting together the rest of the summer ministry team, preparing schedules and camp programs, promoting camp at various churches and getting everyone excited for a

After hosting the Zion Lutheran Church of Warroad Junior High retreat in October, there has been more conversation about ways to promote such events with other Northern Border congregations. Our Sr. High Rekindle Retreat is next up on the 22nd & 23rd and is open to all Highschool Campers looking to spend s'more time out at camp this Spring! We have truly enjoyed building these relationships and strengthening our connections. A huge shout out has to go to Dave Dallager and Keith Zeh for having a vision and including Pathways in all of the fun! And Another Huge Thank you to Deacon Joanne and Jay Ostegard from Messiah in Roseau for their Lock-In retreat in February with kids running worship, great songs, and even better connections forming between Pathways and the Roseau Community! Pathways Facilities Director's Annual Report

Facility Report 2023

Improvements at Camp Emmaus this year came from a group of ambitious workers called the Hard Hat Ministry from Calvary- Park Rapids. They have decided to help Pathways and Camp Emmaus by giving the Chapel a facelift. The first step was to remove the concrete landing to see what was needed under the foundation. Footings and stringers were replaced under the wall due to the age of the building. After that, a nice platform deck filled in the void from the hillside stairs to the chapel. New windows were also added onto the lake side.

Plans to add an exhaust fan to the dishroom were finalized and bids obtained. This is a Minnesota Department of Health regulation to evacuate moisture, prevent condensation, and clear chemicals from the air while using the dishwasher. This is a multi-step process that will be completed spring 2024.

The sale and purchase of Camp Emmaus shed light on some county and state regulations regarding the outdated septic system. A septic design consultant has been working on bringing the non-conforming systems up to code. The bidding process for septic installation will start spring 2024, with a completion deadline of June 2024 per the state. For efficiency and to streamline decision-making, this project has been handed over to the Executive Director.

The fleet of vehicles once again caused unexpected expenses. The big 15 passenger van and the Honda Odyssey both had torque converter seals go out. Transmission overhauls were completed, and we will once again be able to transport our campers to the Challenge Course north of Park Rapids.

As the solo maintenance person on duty all summer, I was not able to spend much extra time at Camp Minne-wa-kan. Aside from some screen repairs and dead/hazardous trees being removed, improvements at Minne-wa-kan have been on hold as the future of this camp is unfortunately up in the air.

It appears that Mother Nature is being generous with our spring (and winter) weather this year, pending any late snow storms. This is a welcomed surprise for me, as spring is always a busy time preparing the camp for the summer season. This spring will be no different, and I'm hoping to be able to get a headstart on the camp opening tasks. After a years-long hiatus, we will hopefully be able to have camp work days this spring, keep an eye out for dates posted soon.

Nominations/Elections for Pathways Board of Directors

By-Laws of Pathways Incorporated, Article II

Section 1 - Membership of the Board of Directors

- a) The Board of Directors shall consist of not less than 12, nor more than 18 members, elected from member congregations.
- b) Election shall be conducted in such a manner that no more than 6 members are elected to three-year terms each year, subject to one consecutive reelection.
- c) Advisory members of the Board of Directors shall be the following who will have voice, but no vote:
- 1. The Executive Director of Pathways
- 2. Any person or persons so appointed by the Board of Directors

Section 2 – Special Areas of Representation of the Board of Directors

- a) At least 4, but not more than 9, of the elected members shall be pastors of the ELCA.
- b) The Board of Directors shall elect a Treasurer for the Pathways Corporation either from within or from outside its membership. If elected from outside its membership, the Treasurer shall be considered an advisory member of the Board, and no limitation of term shall apply ... The term of office shall be one year.c) Each of the conferences shall have at least 2 representative members.
- d) Due consideration shall be given to an equitable distribution of Board members from the areas served.

Nominations for Board of Directors, Endowment Committee and Nominating Committee

The Ballot will be available on Sunday at the meeting.

*Additional nominees from the floor should align with representation from areas served
